

Try Amazon – Seller Offer Terms & Conditions

1. This limited term offer, namely Try Amazon ("**Offer**") is offered by Amazon Seller Services Private Limited ("**Amazon**", "**we**", "**us**" or "**our**").
2. This referral fee waiver Offer is available to India-based sellers who register on sell.amazon.in website or the mobile application thereof (collectively, "**Site**") in accordance with the terms and conditions of this Offer ("**Offer Terms**").
3. This Offer is valid from September 15, 2021 to October 31, 2021 (both days inclusive) ("**Offer Period**"), unless extended or revoked by Amazon in its sole discretion, without any prior notice and without any liability.
4. During the Offer Period, upon successfully completing registration on the Site in accordance with these Offer Terms, you will be eligible to avail up to 50% waiver on referral fee applicable to the sellers, subject to a minimum charge of 2% referral fee and a maximum fee waiver of INR 2,000/- ("**Fee Waiver**").
5. To be eligible for the Fee Waiver, you need to register yourself as a seller on the Site for the first time during the Offer Period. The Offer is available to all new self-service registered and new Karigar sellers on the Site.
